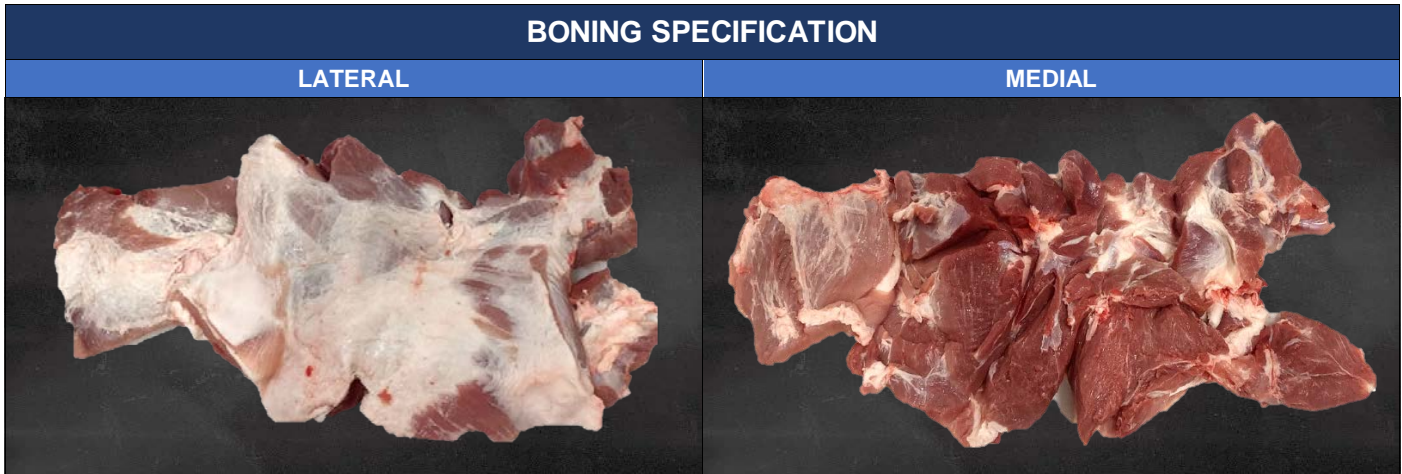

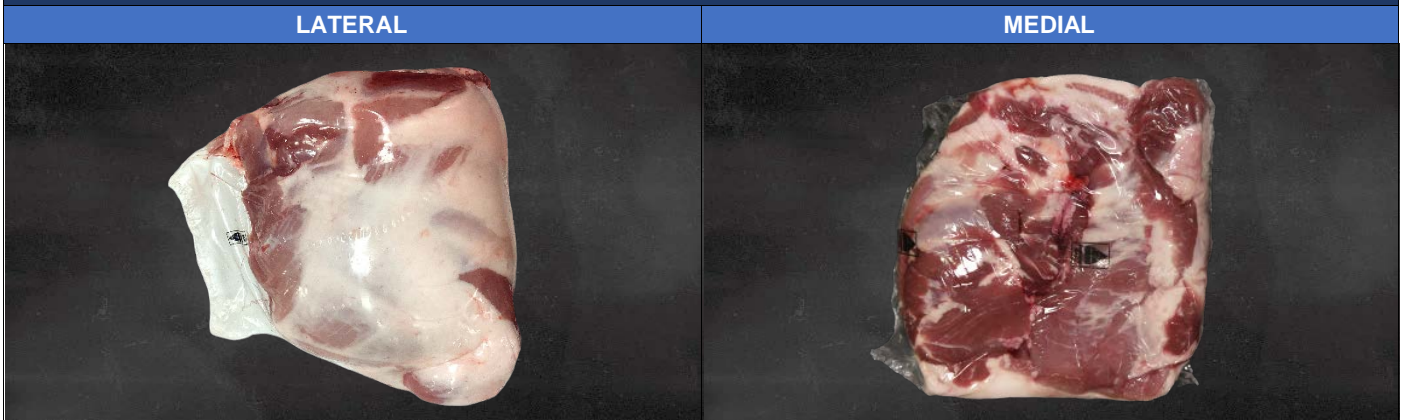
<b>CUTTING FURTHER PROCESSING</b>	<b>PROCESS STEPS</b>	<ul style="list-style-type: none"> <li>Cut square between 4<sup>th</sup>-5<sup>th</sup> thoracic vertebrae</li> <li>Remove fore trotter and fore hock</li> <li>Remove neck bone, sternum bone and riblet</li> <li>Remove scapula bone and humerus bone</li> <li>Remove rind</li> <li>Remove collar butt</li> <li>Trim to visual 85 CL</li> </ul>
	<b>SPECIFICATION POINTS</b>	<ul style="list-style-type: none"> <li>Visual CL: 85</li> </ul>
	<b>DEFECTS</b>	<ul style="list-style-type: none"> <li>Rind retained</li> <li>Incorrect CL</li> <li>Bone chips and cartilage (sail bone)</li> <li>Foreign material (grease, rail dust, plastic, metal etc.)</li> </ul>
